- \$500 of DUI Task Force money was used to pay for Think Twice to be at the Griz Game.

### Action Item: Vote on \$1000 Funding Request - UNANOMIOUSLY APPROVED

A vote to use \$1000 of DUI Task Force Funds to cover the cost of up to 23 Think Twice Media Kits for Missoula County bars and establishments. These kits consist of one poster in a frame, one incident logbook, and 100 bar coasters. Establishments will still be required to purchase two boxes of breathalyzers for \$120 (60 total breathalyzers) which they sell to patrons for \$2.00 each allowing to recover their \$120 investment. The free media kits, sponsored by the DUI Task Force, will be utilized as an extra incentive to establishments who maybe "On the fence" about having "Think Twice" in their establishment.

#### Missoula R.O.A.D. Court Presentation

Lead by Judge Landee Holloway, the Missoula R.O.A.D. Court team, provided an overview of the Missoula County Justice Court R.O.A.D. (Responsibility, Opportunities, and Accountability for Drivers) treatment court.

The R.O.A.D. court is intended to save lives and make roads safer by reducing recidivism events of alcohol and drug-related traffic offenses. The court holds participants accountable for their actions while addressing root problems, treating chemical dependency and co-occurring issues.

The R.O.A.D. court is a comprehensive treatment program for adults who have been charged with a DUI 2<sup>nd</sup> or 3<sup>rd</sup>, aggravated DUI 1<sup>st</sup>, 2<sup>nd</sup>, or 3<sup>rd</sup>, and traffic offenses that involve substance use on a case by case basis. The program is a voluntary program that includes regular court appearances and working with the entire R.O.A.D court team on issues related to transportation, treatment, alcohol & drug testing, community service and accountability & sanctions.

The team presented the Guiding Principles of the court:

- 1. Determine the Population
- 2. Perform a Clinical Assessment
- 3. Develop the Treatment Plan
- 4. Supervise the Offender
- 5. Forge Agency, Organization and Community Partnerships
- 6. Take a Judicial leadership Role
- 7. Develop Case management Strategies
- 8. Address Transportation Issues
- 9. Evaluate the program
- 10. Ensure a Sustainable Program

The team also talked about how a participant moves through the different phases and what is required of them within each phase leading toward graduation.

Judge Holloway announced the R.O.A.D. court has received their funding for this next year which will allow the court to increase the number of participants in the program.

The court is accepting referrals to the court.
