    - Love them (BAC Straws)
    - Just ordered 4 more boxes of BAC Straws
    - Customers see the signs in the bathroom and ask us about the single use BAC Straws
- Met with Missoula Downtown Association
  - Promo Video (posted 24 hours before event)
    - 56 Post Clicks
    - 40 Reactions
    - 199 Minutes Viewed
    - 939 Total Reach
  - Winter Brew Fest Pictures Post Event
    - 216 Post Clicks (Engagement)
    - 58 Reactions
    - 1.100 Total Reach

- Brief description of ROAD Court
- 13 Participants Currently
- Just Completed 1<sup>st</sup> full year
- Received a \$10,000 grant to pay for a Grant Writer to apply for a \$400,000 Grant for expansion and growth of ROAD Court. This will fund the court for 3 years.

- Looking to grow to about 50 participants.
